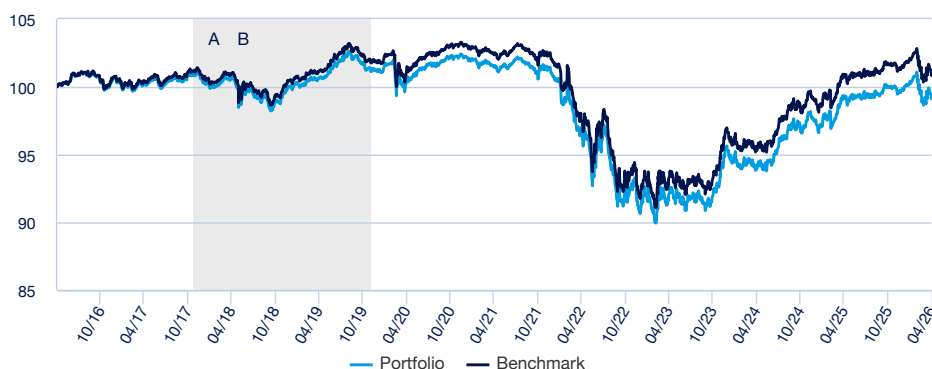

Eligible securities must have maturities of at least 3 years and no more than 5 years, with a minimum outstanding amount of €300m.

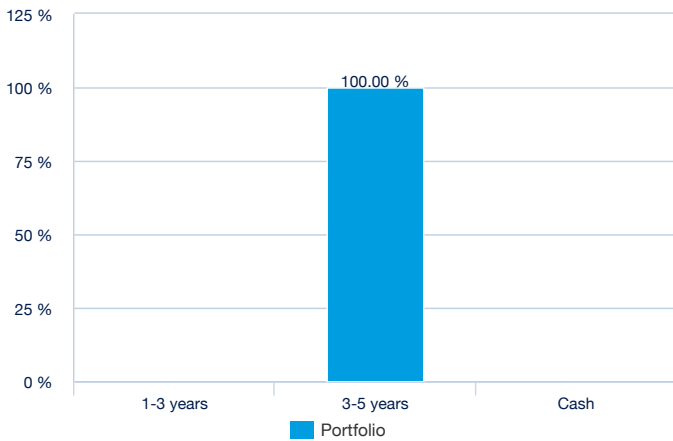
